SUBJECT: MINISTER OF INDUSTRY BLASTS SENATE ACTION

1. CONFIDENTIAL - ENTIRE TEXT.
2. SUMMARY: HUSAYN KAMIL, SADDAM HUSSEIN'S SON-IN-LAW AND MINISTER OF INDUSTRY, FULMINATED TO BECHTEL REPRESENTATIVES SEPTEMBER 10 ABOUT THE SENATE'S PASSAGE OF THE GENOCIDE BILL. IN LENGTHY DIATRIBE, KAMIL DENIED CHARGE OF CW USE AND DESCRIBED SENATE ACTION AS PART OF ZIONIST CONSPIRACY TO EMBARRASS AND UNDERMINE IRAQ AFTER ITS "VICTORY" OVER IRAN. BECHTEL REPRESENTATIVES SAID THAT IF ECONOMIC SANCTIONS CONTAINED IN SENATE ACT ARE SIGNED INTO LAW, BECHTEL WILL TURN TO NON-U.S. SUPPLIERS OF TECHNOLOGY AND CONTINUE TO DO BUSINESS IN IRAQ. END SUMMARY.

BECHTEL REPRESENTATIVES MET WITH AMBASSADOR AND ECONOFF SEPTEMBER 12 TO DISCUSS STATUS OF BECHTEL'S OPERATIONS HERE AND REACTION OF MINISTER OF INDUSTRY TO SENATE PASSAGE OF ACT INVOKING ECONOMIC SANCTIONS AGAINST IRAQ FOR USE OF CHEMICAL WEAPONS AGAINST THE KURDS. THEY SAID THAT HUSAYN KAMIL VENTED HIS SPLEEN FOR ONE AND A HALF

HOURS SEPTEMBER 10 REGARDING THE SENATE'S DECISION.

4. ACCORDING TO BECHTEL, KAMIL SAID THAT THE SENATE ACT CAME AT A TIME OF IMPROVING RELATIONS WITH THE U.S. AND CAUGHT HIS GOVERNMENT COMPLETELY BY SURPRISE. HE DENIED THAT IRAQ WAS USING CHEMICAL WEAPONS AGAINST THE KURDS AND BEMOANED THE FACT THAT THE U.S. WOULD "MIX POLITICS WITH BUSINESS" BY CALLING FOR ECONOMIC SANCTIONS. CLEARLY, HE SAID, THE ZIONISTS WERE BEHIND THE SENATE ACTION, SINCE IRAQ HAD DEFEATED THEIR IRANIAN ALLY AND WAS NOW DEFEATING THEIR KURDISH SURROGATES IN NORTHERN IRAQ.

5. KAMIL INSISTED THAT A CLEAR PATTERN OF "ZIONIST UNDERMINING OF IRAQI-U.S. RELATIONS" IS NOW APPARENT. BY WAY OF EXAMPLE, HE REFERRED TO THE USG'S PAST REFUSAL TO APPROVE IRAQ'S PURCHASE OF BOEING CARGO AIRCRAFT UNDER THE PRETENSE THAT THEY COULD BE USED TO TRANSPORT TROOPS AND, UNDER SIMILAR PRETEXT, ITS REFUSAL TO ALLOW A U.S. MANUFACTURER OF MULTI-PURPOSE VEHICLES TO ASSIST IRAQ IN ESTABLISHING A PLANT HERE. HE CITED CONGRESSIONAL INTERFERENCE TO PREVENT AP-

PROVAL OF THE SALE OF USX'S CLOSED STEEL PLANT IN TEXAS AS THE MOST RECENT EXAMPLE.

6. BECHTEL RECENTLY SIGNED A TECHNICAL SERVICES CONTRACT TO MANAGE THE IMPLEMENTATION OF IRAQ'S PETROCHEMICAL PROJECT II. THE DOLS. 2 BILLION PROJECT INVOLVES THE CONSTRUCTION OF A 450,000 TON/YR ETHYLENE PLANT. U.S. FIRMS HAVE REPORTEDLY WON DOLS. 300 MILLION CONTRACTS TO BUILD THE PLANT (LUMMUS) AND TO SUPPLY ROTATING EQUIPMENT FOR IT (ELLIOT-UNITED TECHNOLOGIES). SHOULD THE SENATE ACT BECOME U.S. LAW, U.S. SUPPLIERS WILL BE PRECLUDED FROM SELLING ITEMS CONTAINING RESTRICTED TECHNOLOGY. BECHTEL REPRESENTATIVES SAID THAT U.S. FIRMS--INCLUDING BECHTEL--WILL RESORT TO NON-U.S. SOURCES TO CARRY OUT THEIR RESPECTIVE CONTRACTS.

7. COMMENT: HUSAYN KAMIL IS ONE OF SADDAM HUSSEIN'S CLOSEST ADVISORS, SOME SAY HIS CLOSEST. THEREFORE, WE TAKE KAMIL'S ANGRY REACTION, ONE DAY AFTER PASSAGE OF THE SENATE GENOCIDE BILL, TO BE AN ACCURATE REFLECTION OF SADDAM'S OWN REACTION.
