PAZ BARNICA CALLED AMBASSADOR AFTERNOON SEPTEMBER 25 TO RELATE THAT GUATEMALAN FOREIGN MINISTER ANDRADE HAD SENT HIM A TELEX DATED SEPTEMBER 24 WITH THE TEXT OF HIS PROPOSED SPEECH ON BEHALF OF ALL CENTRAL AMERICAN FOREIGN MINISTERS AT SAN JOSE. INCLUDED IN TEXT WAS PASSAGE REFERRING TO LATEST CONTADORA ACT WHICH STATES IN PART, QUOTE WHICH WE HAVE CONCLUDED CAN BE ACCEPTED WITHOUT SIGNIFICANT OBJECTIONS END QUOTE.

3. PAZ SAID HE SUBSEQUENTLY RECEIVED TELEX DATED SEPTEMBER 25 CANCELLING PREVIOUS MESSAGE FROM ANDRADE AND SAYING THAT DEFINITIVE REVISED TEXT OF HIS SPEECH WOULD BE SUBMITTED SHORTLY. PAZ EXPRESSED HOPE THAT FOREGOING PASSAGE WOULD NOT APPEAR IN FINAL VERSION AND HOPE THAT SALVADORAN FOREIGN MINISTER TENORIO MIGHT BE ABLE TO INFLUENCE ANDRADE IN RIGHT DIRECTION ON THIS POINT. NEGROPONTE
