SITREP COVERING PERIOD 181000Z DEC TO 191000Z DEC 93.I. GEN SITUATION UNCHANGED. CALMII. FACTIONAL ACTIVITIES.

A. POLITICAL. GOVT OF RWANDA HAS NOT YET CONFIRMED THE LOCATION AND OTHER LOGISTIC ARRANGEMENTS OF RPF BATTALION TO BE PLACED IN KIGALI. UNAMIR MAKING ALL OUT EFFORT TO PURSUE THE GOVT TO MAKE THESE URGENT DECISIONS.
