Justification

Activation of Detachment 6

The following justification is provided according to AFI 38-101.

I. What is the proposed action?

Propose the activation of Detachment 6, Air Force ISR Agency, at Wright-Patterson AFB, OH.

2. Why is this action needed? What are the expected benefits?

Action is requested due to growth of Operating Location Dayton, requiring an on-site commander. The detachment will assume the HUMINT operations mission and will remain under the chain of command of AF ISR Agency/A3. The detachment is the second phase of the HUMINT program development. The intention is to transition the detachment into a squadron during the third phase.

3. What is the structure of the new organization?

Current and proposed organizational charts are attached.

4. How does the structure compare with the standard structure and nomenclature?

The proposed structure is in compliance with AFI 38-101.


Current:
