SUBJECT: Request for Briefings

Judge Clark would like to receive briefings on related military systems and procedures to increase his general understanding of those topics. The first set of such briefings desired would focus on strategic forces, and a suggested agenda for this session is attached.

The preferred timing of the session would be from 4-6 p.m. on February 19th. While this is relatively soon, since the Judge would prefer to receive informational briefings presented directly by the best qualified staff-level experts in a rather informal setting, we hope that this date is acceptable. Finally, since one of the items on the desired agenda is an explanation and demonstration of the tactical warning and attack assessment displays which would support NCA decision making in a crisis, we would appreciate the opportunity to receive this entire set of briefings in the NMCC complex, if possible.
