a. 25 February 1959 Minutes

"The DCI pointed out to the Group that there are a number of Agency programs under way which began before the approval of NSC 5412/2 and thus the establishment of the Special Group."

B. 4 March 1959 Minutes

"The DCI showed the Group the summary of actions approved by it since its inception. Mr. Alexis Johnson also affirmed that constant reviewing was being done in the Department of State and that he was satisfied with the importance and necessity of the covert action activities currently undertaken by CIA." (We have the briefing outline used by the DDP on covert political action and PM projects. Mr Meyer covered "all other covert action" but no outline is available. It is likely that he covered Youth and Student activities.)

"World Youth Festival - The CIA paper entitled, "Program of Covert Counteraction against the 9th World Youth Festival, Algiers, August 1965," was approved promptly. Mr. McCone noted that the site of this event would produce more difficulties than those encountered in the relatively friendlier areas of Helsinki and Vienna. Mr. Bundy observed that he was personally acquainted with the considerable educative impact on young Americans participating in this type of confrontation with a Communist organization, a useful by-product to an important effort." (The paper referred to does not detail the instruments available to CIA to carry out the covert action. It implies the use of democratic youth and student organizations.)

Mr. Meyer then went on to point out that this was only one conspicuous example of a problem which would grow larger, and he specifically mentioned the need of a new institution created by legislation and based on British Council lines which could provide general support grants to this and similar organizations whose activities are of proven value to the United States abroad.

He cited a speech by Eugene R. Black at the recent Wesleyan University commencement dealing with grants in aid. . It was emphasized that substantial private contributions and those of foundations are inhibited, if not precluded, by CIA association with Mr. Rostow pointed out EO 12958 3.4(b) such organizations that the CIA had many times taken up the slack when other agencies (C) were unable to come up with funds. Mr. Meyer's suggestion was greeted with considerable interest, and Mr. Helms suggested that any committee on this subject be headed in the White House in order to give it sufficient impetus. Mr. Moyers agreed to approach Mr. Harry McPherson and urged that talks continue between Mr. Meyer, Mr. McPherson and other interested parties. It was noted that although the committee would not operate under 303 aegis, its determinations and findings might well have a bearing on future proposals before the 303 Committee."
