Records of the U. S. Embassy, Citizenship Section, Buenos Aires, Argentina, indicate that the above captioned individual appeared at the Embassy on May 12, 1975, in order to register as a United States citizen and to renew her United States Passport.

Embassy records indicate that LOKEN previously held United States Passport J1155404, which was issued on December 31, 1968, in New York City. A new United States Passport Z2212541 was issued on May 12, 1975, valid until May 11, 1980. LOKEN indicated that she first arrived in Argentina on July 29, 1973, in order to take up permanent residence with her husband, HORACIO GUILLERMO LOPEZ, noting that she married in Rosario, Santa Fe Province, Argentina, on December 12, 1972. LOKEN indicated her husband was born on [redacted] in Rosario, Argentina, and is an Argentine citizen.

LOKEN reported that she was born on [redacted] in Philadelphia, Pennsylvania, to MERLE KENNETH LOKEN, who was born on January 21, 1925, and FERN MAE BUHLER, who was born on January 16, 1927. LOKEN indicated she has Social Security Number [redacted]. LOKEN reported that she resides at Boulevard Orono 1388, Apartment 1B, Rosario, Santa Fe Province, Argentina.

LOKEN se caso 12/12/72 con HORACIO GUILLERMO LOPEZ quien nacio [redacted] en Rosario. LOKEN es miembro desde 27/10/71 de la Alianza Socialista de Jovenes en Minneapolis, Minnesota.

Este investigacion esta basada en informacion recibida la cual indica que la organizacion bajo el nombre de Alianza Socialista de Jovenes (ASJ) esta envuelta en actividades que podrian conllevar violaciones de las leyes delCodigo de los Estados Unidos, Titulo 18, #2383 (Rebelion o Insurreccion), #2384 (Conspiracion Sediciosa), #2385 (Propulsar el Derrocamiento del Gobierno, o sea Titulo 50, Codigo de los Estados Unidos 781-798 (Decreto de Seguridad Interna del 1950 y Decreto de Control Comunista del 1954).

La ASJ es la rama juvenil del Partido Socialista de los Trabajadores (PST).

La PST es una organizacion de seguidores de la filosofia de Trotsky la cual fue fundada en los Estados Unidos durante el ano 1938, con oficinas centrales en la actualidad en la ciudad de Nueva York. La PST fue calificada por el Fiscal del Estado el 4 de diciembre del 1947 y el 21 de septiembre del 1948 como una organizacion con caracter subversivo y comunista cuyo objetivo es "derrocar la forma de gobierno de los Estados Unidos por medios inconstitucionales." Aun cuando la PST, asi como el Partido Comunista de los Estados Unidos, no hacen politica abierta a favor del derrocamiento del Gobierno de los Estados Unidos por el presente, ni tampoco cometer violaciones contra las leyes civiles o estatales, la PST tiene la creencia de que la eventual revolucion para el derrocamiento del presente sistema de gobierno capitalista en los Estados Unidos es inevitable. Los objetivos de la PST, como las del Partido Comunista de los Estados Unidos, son organizar miembros que tomen accion para precipitar dicha revolucion cuando las condiciones sean propicias y para dirigir y controlar la revolucion cuando la misma se lleve a cabo.
