3. A KEY CAMPAIGN AIDE TO LIBERAL PARTY PRESIDENTIAL PRE-CANDIDATE ERNESTO SAMPER, CESAR VILLEGAS, TOLD POLCOUNS THAT HE HAD NO DOUBTS THAT HIS MAN WOULD TAKE HIS PARTY'S NOMINATION. THE CONTEST IS NOT FOR THE NOMINATION -- "WE WILL GET THAT" -- IT IS FOR THE PRESIDENCY AND THE MAN TO BEAT IS CONSERVATIVE ANDRES PASTRANA, VILLEGAS SAID. "I HAVE NO DOUBT THAT THE NEXT TWO PRESIDENTS OF COLOMBIA (1994 AND 1998) WILL BE SAMPER AND PASTRANA." "WHAT I DO NOT KNOW IS WHICH OF THE TWO WILL BE ELECTED IN '94 AND WHICH IN '98."

LIKE HUMBERTO DE LA CALLE, SAMPER'S CHIEF RIVAL FOR THE LIBERAL PARTY NOMINATION (REFTEL), VILLEGAS WAS CONCERNED ABOUT THE INFLUENCE AD M-19'S ANTONIO NAVARRO WOLFF WILL WIELD IN THE NEXT ADMINISTRATION. (COMMENT: BOGOTA'S POLITICAL SAVANTS ARE IN ACCORD THAT BECAUSE THERE WILL BE AT LEAST THREE CANDIDATES IN THE PRESIDENTIAL ELECTION IN MAY OF 1994, NONE WILL WIN A CONFIDENTIAL

7. SAMPER PLANS TO RETURN TO COLOMBIA SOMETIME IN APRIL, VILLEGAS SAID, THOUGH HE WON'T OFFICIALLY BEGIN HIS CAMPAIGN UNTIL LATE SUMMER. IF THE GOC FAILS TO GET PABLO ESCOBAR, HOWEVER, SAMPER WILL DELAY HIS RETURN IN ORDER TO DISTANCE HIMSELF TO THE EXTENT POSSIBLE FROM CURRENT PRESIDENT AND TITULAR HEAD OF THE LIBERAL PARTY CESAR GAVIRIA, WHOSE PERSONAL POPULARITY REMAINS QUITE LOW IN LARGE PART BECAUSE OF ESCOBAR.

8. VILLEGAS CONFIRMED THAT FORMER PEACE COUNSELLOR HORACIO SERPA WOULD RUN THE SAMPER CAMPAIGN; FORMER COLOMBIAN AMBASSADOR TO THE UN ENRIQUE PENALOSA WILL BE CAMPAIGN TREASURER.

9. VILLEGAS WORRIED THAT ALLEGATIONS OF INVOLVEMENT WITH NARCOTICS TRAFFICKERS MIGHT BE LODGED AGAINST HIMSELF, SENATOR ALVARO URIBE (ALSO A KEY SAMPER SUPPORTER) AND SAMPER. HE SAID HE WAS CAUTIONING SAMPER THAT THE CAMPAIGN HAD TO BE DESIGNED TO AVOID TO THE EXTENT POSSIBLE SUCH CHARGES.

10. COMMENT: RUMORS OF THE INVOLVEMENT OF THESE THREE WITH NARCOTICS TRAFFICKERS ABOUND, AND ALTHOUGH HARD EVIDENCE IS LACKING IN ALL CASES, WE BELIEVE THERE IS SUBSTANCE TO THE RUMORS. IT IS NOT CLEAR HOW CLOSE THE
