2. I SPOKE TO DOCTOR SUAZO ON THE MORNING OF SATURDAY, MAY 4, ABOUT THE DESIRABILITY OF ANNOUNCING HIS VISIT TO WASHINGTON AS SOON AS POSSIBLE. I ALSO EXPLAINED TO HIM THAT I WOULD BE IN WASHINGTON MOST OF NEXT WEEK IN CONNECTION WITH MY CONFIRMATION HEARINGS.
3. SUAZO SAID HE UNDERSTOOD THE IMPORTANCE OF NOT PUTTING OFF AN ANNOUNCEMENT UNTIL THE LAST MINUTE AND ASSURED ME THAT WE COULD EXPECT DEFINITIVE WORD FROM HIM NEXT WEEK. HE DID, HOWEVER, FIRST WANT TO GET A PERSONAL BRIEFING FROM THE GOH DELEGATION WHICH WENT TO WASHINGTON ON THE PROGRESS OF OUR BILATERAL TALKS. MOST MEMBERS OF GOH TEAM, SUAZO SAID, WERE RETURNING THIS WEEKEND. NEGROPONTE
