

MEMBERS OF THE FRONTIER CORPS OF WHO HAVE CANDIDLY DESCRIBED THEIR INVOLVEMENT IN AFGRANISTAN.

APPARENTLY, COMPANY SIZE ELEMENTS FROM THE FRONTIER CORPS ARE USED ALMOST EXCLUSIVELY ACROSS THE BORDER. BECAUSE THE COMPOSITION OF FRONTIER CORPS NAFP IS TOTALLY PASHTUM AND FRONTIER CORPS BALOCHISTAN IS PREDOMINANTLY PASHTUM. THESE INDIVIDUALS EASILY BLEND IN WITH THE AFGHAN PASHTUM POPULATION. THESE FRONTIER CORPS ELEMENTS ARE UTILIZED IN COMMAND AND CONTROL; TRAINING; AND WHEN HECESSARY—COMBAT. ELEMENTS OF PAXISTAN'S REGULAR ARMY FORCE ARE NOT USED BECAUSE THE ARMY IS PREDOMINANTLY PUNIABL, WHO OTHER AFGHAN TRIBES. ADDITIONAL REASONS FOR UTILIZING FORMATS.

- -- THE OFFICERS ARE PUSHTUN, REGULAR ARMY OFFICERS.
 -- CONSOLIDATED UNITS, WHICH HAVE PERSONNEL WHO HAVE SERVED TOGETHER THROUGHOUT THEIR SERVICE, CAN BE UTILIZED.
- -- THEY ARE VERY WELL TRAINED AND ARE PARTICULARLY

SUITED FOR THIS TYPE OF SCENARIO.

THESE SAME SMUGGLERS HAVE ALSO ESTABLISHED FLIGHTS INTO KANDAHAR AND PESHAWAR FROM DUBAI. THE CUSTOMS HOUSES, JM, KANDAHAR AND PESHAWAR COLLECT TAXES ON GOODS ARRIVING ON THESE AIRCRAFT.

18. PERIODICALLY MEETS HAJI (IBASHIR) I THAT MULLAH (MAJOR ORUG DEALER). BASHAR WAD TOLD THAT MULLAH IN BASHAR'S MOSQUE AND THAT IN THE EARLY STAGES OF THE TALIBAN MOVEMENT. BASHAR GAVE OMAR EIGHT HILLION RUPEES
APPROX 258-888 USD AT THAT TIME).

DESCRIBED BASHAR AS A JALL PATHAN FROM THE MODZAI TRIBE. APPROX 35 YEARS OLD. BASHAR HAD BEEN IN QUEFTA TWO MEEKS AGO AND WAS NOW ESTHER IN HERAT. KANDAHAR OR DUBA!. BASHAR RAS A HOUSE IN SATELLITE TOWN.

A RIFT EXISTS WITHIN THE TALIBAN HIERARCHY. SOME OF THE SENIOR FALIBAN LEADERSHIP ACCUSE MULIAN RABBANI FOR THE DEATH OF MULIAN BORJAM. PRIOR TO THE BATTLE FOR KABUL, BORJAN APPARENTLY GAVE EXPLICIT INSTRUCTIONS TO HIS PERSONNEL THAT HASIBULLAN WAS TO BE ARRESTED AND WOULD RECEIVE A FAIR TRIAL. RABBANI STRONGLY DISAGREED, STATING THAT MAJIB HAD MURDERED HIS FATHER AND BROTHER. RABBANI TOLD BORJAN HE

WOULD NOT FORGET THIS AND THAT HE INTENDED TO KILL HAJIB. HARD FEELING EXISTED BETWEEN RABBANI AND BORJAN AFTER THIS CONVERSATION. -- SEVERAL DAYS LATER, BORJAN VAS SHOT AND KILLED.
