AMBASSADOR REVIEWED REF A U.S. POINTS CONCERNING

"CHARGE" HAQQANI AND HIGH-LEVEL PAKISTANI
MINISTRY OF FOREIGN AFFAIRS OFFICIAL IFTIKHAR
MURSHED. HAQQANI PROMISED TO CONVEY THE U.S.
MESSAGE TO THE TALIBAN LEADERSHIP. ASSERTING
THAT THE GOP TOOK THE ISSUE VERY SERIOUSLY,
MURSHED SAID PAKISTAN WOULD RAISE THE MATTER WITH

- 2. (S) THE AMBASSADOR MET MAY 29 WITH "CHARGE D'AFFAIRES" OF THE TALIBAN-CONTROLLED AFGHAN EMBASSY, SYEDUR RAHMAN HAQQANI. AMBASSADOR CAREFULLY REVIEWED REF A POINTS, UNDERSCORING THE SERIOUSNESS OF THE SITUATION, AND REQUESTING THAT THE U.S. POINTS BE PROVIDED TO THE TALIBAN LEADERSHIP AS SOON AS POSSIBLE.
- 3. (S) HAQQANI LISTENED VERY CAREFULLY. HE REPLIED THAT THE U.S. POINTS WOULD BE CONVEYED TO THE AMIR AL-MUMINEEN (TALIBAN LEADER MULLAH OMAR) AND THE TALIBAN "MINISTRY OF FOREIGN AFFAIRS" IN KABUL. HE SAID THE TALIBAN IN THE PAST HAD INFORMED THE U.S. THAT BIN LADIN WOULD NOT BE ALLOWED TO UNDERTAKE ANTAGONISTIC ACTIONS AGAINST ANYONE, INCLUDING THE U.S. HOWEVER, THE U.S. SECRET

HAQQANI ASSERTED THAT HE AND THE TALIBAN HAVE NO IDEA OF WHERE BIN LADIN NOW WAS. HOWEVER, HAQQANI ADDED, HE "BELIEVED" THAT BIN LADIN WOULD NOT UNDERTAKE ANY ACTION AGAINST THE U.S. HOWEVER, THE U.S. SHOULD UNDERSTAND THAT SOME THIRD PARTY MIGHT CREATE AN INCIDENT IN ORDER TO BLAME BIN LADIN AND THE TALIBAN.

(S) CONTINUING, HAQQANI SAID THE TALIBAN WANTED TO REPAIR RELATIONS WITH THE U.S. THE TALIBAN UNDERSTAND THAT THERE ARE OBSTACLES THAT THE U.S. IS WORRIED ABOUT. THE TALIBAN WANT THOSE OBSTACLES TO BE REMOVED. TO DO THIS, (TALIBAN KANDAHAR-BASED "DEPUTY FOREIGN MINISTER") MULLAH JALIL HAD MET WITH (ASSISTANT SECRETARY FOR SOUTH ASIAN AFFAIRS) INDERFURTH AND THEN (CHARGE D'AFFAIRES) EASTHAM (SEE REFS C AND D, WHICH REVIEWED THE FEBRUARY AND MAY MEETINGS, RESPECTIVELY). THE TALIBAN HAVE NO BAD INTENTIONS AGAINST ANY COUNTRY, ESPECIALLY THE U.S. THE TALIBAN WANT TO DEAL WITH THIS MATTER, BUT BIN LADIN IS LIKE "A BOMB" FOR THEM. IF THE TALIBAN EXPEL HIM, THEN THE PEOPLE -- WHO ALL SUPPORT HIM --WILL RISE UP AGAINST THE TALIBAN. THE TALIBAN CANNOT ASSUME THAT RISK. 6. (S) WE ARE RELATIVELY CONFIDENT THAT HAQQANI WILL PASS THE REF A MESSAGE TO THE TALTBAN LEADERSHIP AS SOON AS POSSIBLE. HE IS SAID TO HAVE CLOSE LINKS WITH KANDAHAR, INCLUDING WITH MULLAH OMAR. UNFORTUNATELY, ALTHOUGH HE SEEMED TO BE TRYING TO BE SOLICITOUS AND FRIENDLY, NOTHING HAQQANI ACTUALLY SAID WAS NEW, I.E., HE MADE NO PROMISES THAT THE TALIBAN PLANNED TO DEAL WITH THE BIN LADIN MATTER ONCE AND FOR ALL. HE ALSO REPEATED THE TALIBAN CANARD THAT THEY DO NOT KNOW WHERE HE IS. AS FOR MURSHED, HE ALSO SAID NOTHING NEW. HE ADMITTED THAT-IN HIS OTHER GUISE AS CHIEF OF THE MFA S POLICY PLANNING OFFICE -- HE WAS NOW PREOCCUPIED WITH THE RECENT INCREASE IN INDO-PAKISTANT TENSIONS OVER KASHMIR. NONETHELESS, HE PROMISED THAT THE GOP WOULD PRESS THE TALIBAN ON THE MATTER. END COMMENT.
