ACCORD ON SOVIET TROOPS IN RUMANIA: USSR DELEGATION HEADED BY GROMYKO AND ZHUKOV ARRIVED BUCHAREST APRIL 14 TO "PERFECT AND SIGN" ACCORD RE "TEMPORARY" SITUATIONING SOVIET TROOPS RUMANIAN SOIL NEGOTIATED REGENT MONTHS ON BASIS SOVIET-RUMANIAN UNDERSTANDINGS REACHED MOSCOW EARLY DECEMBER 1956 (SEE JOINT WEEKA 4 ACCORD SIGNED 15TH, PUBLISHED 17TH; CONCERNED WITH MATTERS JURISDICTION AND POSSIBLE OCCASIONS LITIGATION FOR DAMAGES, IN CONVENTIONAL DOCUMENT WITH DECIDED TENDENCY EMPHASIZE RUMANIAN JURISDICTION. WHILE ARTICLE TWO PROVIDES NUMBER AND LOCATION SOVIET FORCES RUMANIAN SOIL SHALL BE SUBJECT SPECIAL CONVENTION PRESENT ACCORD MAKES NO (REPEAT NO) REFERENCE NUMBERS, CHARACTER LOCATION THESE FORCES NOW OR FUTURE.

LEGATION COMMENT: SUBSEQUENT TO HUNGARIAN UPRISING WAS EVIDENTLY REALIZED HUNGARIAN LAND AREA AND ARMED FORCES LESS EFFECTIVE BUFFER THAN EARLIER THOUGHT, AND RUMANIAN TROOPS ARE TRAINING
