Briefing Sheet for the Chairman, JCS, on a report being processed under MOP 97 and scheduled for approval on 12 May 1981.

Subject: JCS 2517/193 - Exercise IVY LEAGUE 82 (U)

1. (U) Purpose - On 12 Jan 1979, the Joint Chiefs of Staff approved the JCS-Directed and JCS-Coordinated Exercise Schedule for FY 1980-1984 which authorizes Exercise IVY LEAGUE 82.

- On 5 Mar 81, Tab B, Services, the unified and specified commands and US Coast Guard were informed of the preliminary concept, objectives, and planned dates for Exercise IVY LEAGUE 82.

2. (S) Key points to be considered - Tab A contains a memorandum for the SECDEF with proposed memorandums for SECSTATE and Director, FEMA, and a memorandum for unified and specified commands, Services, and defense agencies informing them of the concepts and objectives for Exercise IVY LEAGUE 82.

- Exercise IVY LEAGUE, scheduled for 1-5 March 1982, simulates execution of SIOP and non-SIOP options. Other objectives include exercise of CANUS defense plans, logistic procedures, tactical warning, attack assessment, military support to civil defense and WWMCCS.

- Exercise is linked by common scenario with Canadian CPX BOLD STEP 82; FEMA Continuity of Government (COG) Exercise/Evaluation, NINE LIVES 4; ADCOM CPX VIGILANT OVERVIEW; and FEMA CPX REX 82 ALPHA.

- In addition to CINC and Service participation, expect senior DOD and civil agency participation as a result of developing Presidential interest in the NINE LIVES 4 evaluation. Canadian participation in BOLD STEP includes ministerial level.

3. (U) Coordination - J-4, J-5, C3S, DAS, SAGA.

4. (U) Service positions - The Services have concurred in processing this paper under the provisions of MOP 97 and are expected to support the paper as written.

5. (U) Joint Staff concerns - DIA, DCA, DMA, DNA, DLA and NSA/CSS were consulted in the preparation of this report and are expected to support the recommendation.

6. (U) Recommendation - The Director, J-3, recommends that the Chairman, JCS, support the report as written.
