AS REFLECTED IN REFS, THE PARTICIPANTS OF THIS MEETING CONCLUDED THAT THE CONTINUED RETENTION OF THESE TAPES, WHICH IS NOT/NOT REQUIRED BY LAW, REPRESENTS A SERIOUS SECURITY RISK FOR PARTICIPATING IN PARTICIPATING IN PARTICIPATING IN ADDITIONAL CONCERNS DESCRIBED IN REFS, SUCH AS THE DANGER TO ALL AMERICANS SHOULD THE TAPES BE COMPROMISED.
