(C) PELLETREAU STRESSED THAT THE U.S. HASN'T ASKED THAT OTHERS FOLLOW OUR LEAD IN APPLYING A FULL EMBARGO ON IRAN, BUT WE ASK OUR FRIENDS AND PARTICULARLY THE EUROPEANS TO DISCOURAGE COMPANIES FROM FILLING IN BEHIND U.S. COMPANIES, TO NOT INCREASE OIL IMPORTS FROM IRAN, AND TO NOT EXTEND CREDITS OR FINANCIAL ASSISTANCE. THE U.S. SEEKS A TIGHTENING OF CONSTRAINTS WITHOUT A TOTAL EMBARGO,

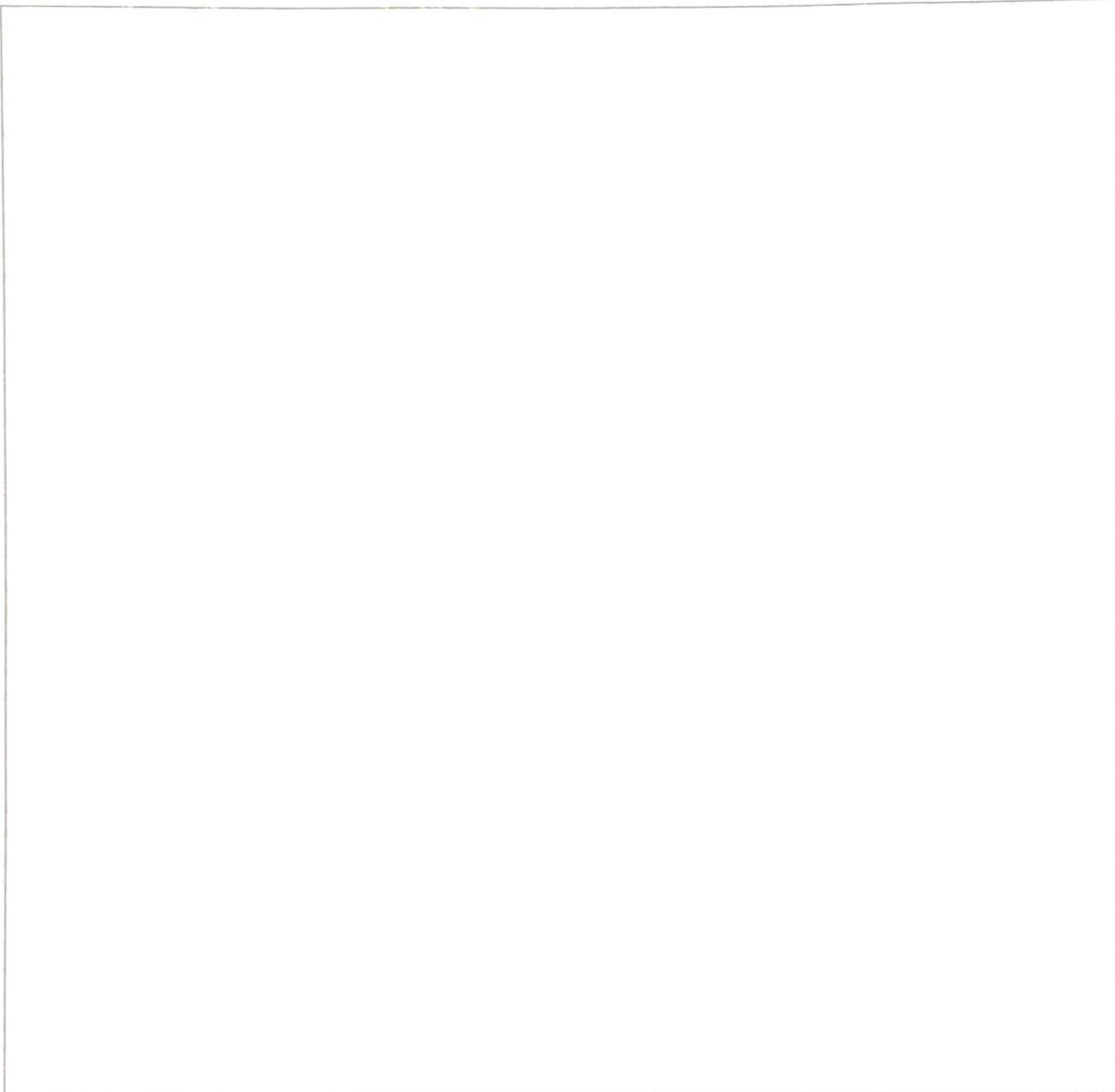
