ON "CONDOR" PLANNING SHOULD BE READ IN CONJUNCTION WITH

FROM THE SAME SOURCE WHICH DESCRIBE

A COOPERATIVE ARRANGEMENT AMONG THE MILITARY INTELLIGENCE SERVICES OF CHILE, ARGENTINA, BOLIVIA, PARAGUAY, URUGUAY, AND BRAZIL TO COUNTER TERRORISM AND SUBVERSION. ACCORDING TO THE BASIC MISSION OF "CONDOR" TEAMS BEING SENT TO OPERATE IN FRANCE WOULD BE TO LIQUIDATE TOP-LEVEL TERRORIST LEADERS. WHILE BRAZIL, BOLIVIA AND PARAGUAY AGREED TO ADHERE TO THE AGREEMENT TO MOUNT OPERATIONS IN FRANCE, THE SOURCE BELIEVED THAT THE BULK OF THE EFFORT WOULD PROBABLY BE CARRIED ON BY ARGENTINA, CHILE AND URUGUAY.)

2. CONDOR WILL BE DIVIDED BUREAUCRATICALLY INTO TWO MAJOR GROUPINGS: "CONDORTEL," WHICH WILL HANDLE THE COMMUNICATIONS ASPECTS, AND "CONDOREJE" (CONDOR AXIS), WHICH WILL BE RESPONSIBLE FOR OPERATIONAL ACTIVITIES. EACH OF THE SIX CONDOR COUNTRIES IS TO SEND TWO OFFICERS TO BUENOS AIRES TO MAN A FORWARD COMMAND AND COORDINATING OFFICE. THIS WILL BE DISTINCT FROM THE CENTRAL ARCHIVES OFFICE OF CONDOR WHICH IS TO BE LOCATED IN SANTIAGO.

3. CHILE, ARGENTINA, AND URUGUAY, THE CONDOR COUNTRIES WHICH WILL OPERATE IN EUROPE, ARE NOW CONSIDERING POSSIBLE TARGETS. CHILE HAS "MANY" (UNIDENTIFIED) TARGETS IN EUROPE. TERRORISTS SUCH AS HUGO ANDRES C O R R E S PEREZ, A LEADER OF THE POPULAR REVOLUTIONARY ORGANIZATION-33 [REDACTED] DEFINITELY WILL BE INCLUDED ON THE URUGUAYAN LIST. THE URUGUAYANS ALSO ARE CONSIDERING TARGETS WHO ARE NOT TERRORISTS, SUCH AS URUGUAYAN OPPOSITION POLITICIAN WILSON F E R R E I R A b1 per CIA ALDUNATE, IF HE SHOULD EVER TRAVEL TO EUROPE. SOME LEADERS OF AMNESTY INTERNATIONAL MIGHT BE SELECTED FOR THE TARGET LIST. [REDACTED]

4. ONCE CONDOR TARGETS ARE FIXED, IT WILL BE THE MISSION OF THE CONDOR REPRESENTATIVES BEING SENT TO PARIS TO PRODUCE INTELLIGENCE ON WHERE THE SPECIFIC TARGETS ARE RESIDING. THIS INTELLIGENCE WILL BE [REDACTED] THE FORWARD COMMAND AND COORDINATING UNIT IN BUENOS AIRES AND OFFICIALS FROM THE UNIT WILL THEN BE DISPATCHED [REDACTED]
