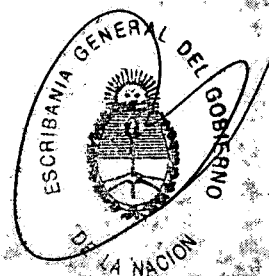

SECURITY OF BUENOS AIRES OFFICE PERSONNEL.

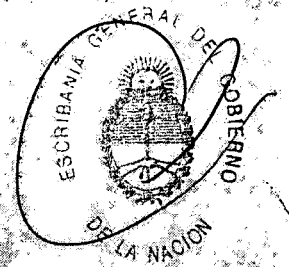
FOR INFORMATION, THE EMBASSY MOBILE SECURITY PATROL REPORTED AT APPROXIMATELY 1:30 A.M., AUGUST 11, 1976, THAT THERE WAS A SHOOTOUT IN PROGRESS IN LA LUCILA, BUENOS AIRES PROVINCE, BETWEEN ARGENTINE SECURITY FORCES AND PRESUMED TERRORISTS. SUBSEQUENT INQUIRY BY THE EMBASSY MOBILE SECURITY PATROL ESTABLISHED THAT UNITS OF THE ARGENTINE ARMY INTELLIGENCE SERVICE OPERATING WITH THE BUENOS AIRES PROVINCIAL POLICE HAD RAIDED AN APARTMENT IN LA LUCILA, BUENOS AIRES PROVINCE, AND ARRESTED A FEMALE OCCUPANT OF THE FIRST FLOOR, WHOSE PARENTS RESIDE IN THE SAME APARTMENT BUILDING ON THE SIXTH FLOOR. THE INDIVIDUAL ARRESTED WAS A PRESUMED TERRORIST. IT IS NOTED THAT THE LOCATION OF THE SHOOTOUT AND ARREST AS DESCRIBED ABOVE IS THE APARTMENT BUILDING WHERE CLERK STENOGRAPHER JOSEPHINE R. NAVARRO OF THE BUENOS AIRES OFFICE RESIDES. AT NO TIME WAS MRS. NAVARRO IN ANY PHYSICAL DANGER AND THE SECURITY FORCES WITHDREW FROM THE AREA AT APPROXIMATELY
