intrusions into computer systems located at Wright-Patterson Air Force Base (WPAFB), Dayton, Ohio. The intrusions appear to be originating from Russia, hopping through the University of Cincinnati (UC), Cincinnati, Ohio, then terminating at WPAFB. The unknown intruder(s) has transferred several sensitive, though not classified, files to Russia. The transferred files generally are word processing and/or power point presentations dealing with cockpit design and computer chip schema.

(U) ~~(S)~~ Investigation has revealed that the unknown intruder(s) has made connections to various other educational sites not previously seen. [redacted]

DCFL will promptly return all original evidence to FBI Cincinnati for proper storage.
