## DEFENDANT'S MOTION FOR A STAY IN LIGHT OF THE COVID-19 PANDEMIC'S EFFECT ON FEDERAL GOVERNMENT OPERATIONS

Defendant hereby moves for an order staying proceedings in this case due to the major adverse impact of COVID-19 on Freedom of Information Act ("FOIA") processing functions of the U.S. Department of State ("State"). Pursuant to Local Rule 7(m), Defendant has sought Plaintiff's position on this request and Plaintiff has indicated there is no objection to this request.

In support of this motion, Defendant submits the attached declaration of Michael Brobeck, Director of the Office of Facilities and Services at the Defense Intelligence Agency.

Consistent with guidance across the federal government, including from the Department of Defense and the Office of Personnel Management, the Director of DIA has directed all personnel who are not essential to DIA's core missions to remain at home..

Declaration of Michael Brobeck ("Brobeck Decl.") ¶ 3. In accordance with this guidance DIA - FOJA officer have been directed to stay at home, rather than report to their work locations.

Likewise many officers from other components of the Agency with whom DIA's FOIA office

works to identify and review potentially responsive records have been also sent home pursuant.to

this health guidance. Id.

The Agency has been encouraging officers to telework when possible. However, FOIA

collection or processing cannot be done remotely by telework-as the systems responsible for

searching for responsive material are classified systems, and all classified systems and materials

must be maintained within a Secure Compartmented Information. *Id.*at ¶ 4.

Under these circumstances, DIA has had to defer FOIA production, including

production relating to matters in litigation since approximately March 17, 2020. The Agency will

resume processing activities as soon as practicable after normal government operations are

restored. Id. ¶ 6.

WHEREFORE, in light of these unique and unprecedented circumstances, Defendant

requests that this case be stayed and all current deadlines be adjourned until further notice.

Defendant proposes to file a status report by May 5, 2020, and continuing every thirty (30) days

thereafter, advising the Court whether the affected personnel have been cleared to resume work

and, if so, proposing a revised schedule for productions to resume in this case. A proposed

order accompanies this motion.

#### OMNIBUS DECLARATION OF MICHAEL BROBECK

I, Michael Brobeck, do hereby declare as follows:

Defendant.

- I am a member of the Defense Intelligence Senior Executive Service, and presently serve as the Director of the Office of Facilities and Services at the Defense Intelligence Agency. I assumed this role in January 2020.
- 2. As Director of the Office of Facilities and Services, one of the branches that I am responsible for is the Records Management and Information Services Branch, which includes the Freedom of Information Act (FOIA) Services Section for DIA. The FOIA office receives, processes, and responds to requests for DIA records under the FOIA and the Privacy Act.
- 3. Consistent with guidance across the federal government, including from the Department of Defense and the Office of Personnel Management, the Director of DIA has directed all personnel who are not essential to DIA's core missions to remain at home. This
