telligence and interrogation techniques, and tend to be extremely secretive. is has caused serious problems for the other intelligence services. When DINA ersonnel, many of whom work clandestinely, detains someone or go on an operation sey tell people that they are with Army, Navy, etc. Intelligence. Subsequently, ien complaints are made about incidents related to the detention or operation say are directed to the Ministry of Defense or the individual services. Checks writably reveal that the DINA was involved. This has the services extremely set because they must spend considerable the checking out the complaints and scause it is giving them a bad name.

c. AAnother major problem of the DINA is it, system of interrogation. Source id that their techniques are straight out of the Spanish Inquisition and often wave the person interrogated with visible bodily damage. The CECIFA and service telligence departments are upset about this, essentially feeling that in this by and age there is no excuse for the use of such primitive techniques. Source id that CECIFA and service intelligence department interrogations usually take lace in the presence of a qualified medical doctor to insure no permanent physical. rental damage is dons to the person being interrogated.

d. S-s referred to the Ministry of Defense Circulars (references (c) and i)) and said that the Circulars have been generally well received by all levels f the military and Carabinero establishments and that the instructions are being illowed with few exceptions. Last week three Army generals were sent to Tenuco o investigate a violation Of the Circulars and another violation was investigated i Valparaiso. Source said that the CECIFA is very concerned about the treatment f detainees but that the supervision of interrogations is a very difficult thing, here are so many things for the armed forces to do at one time that some things sturally go unreported or uncontrolled.

e. The Chief of CECIFA, LCDR Rail MONSALVE, has strongly opposed the methods nployed by the DINA and critical of its subordination to General PINOCHET vice he Ministry of Defense. After one recent meeting at the Ministry, he was told y General Nicanor DIAZ, Acting Chief of the National Defense Staff, to moderate is objections about DINA or face the possibility that DINA personnel would abricate an 'incident" which would destroy his career and get him out of their gy. (LCDR MONSALVE's reaction to this warning was not stated.)

f. The service intelligence departments and the CECIFA personnel refer to INA as 'the monster", reflecting their apprehension about its growing power nd size.

. -(S/NKD) COMMENTS: A. If source's comments on the DINA are true, even admitting ource is prejudiced on the matter, it seems as though it is developing into . BG-type organization as originally predicted in reference (d).

. The matter of physical coercion during interrogations is one of extreme ensitivity, but evidently being practiced by the various intelligence services. ource admits that it takes place, even though s-e evidently sees it, controlled r uncontrolled, as regretable and something which must be controlled.
