3. MARIANA CALLEJAS, THE FORMER WIFE OF MICHAEL TOWNLEY, DROPPED BY THE EMBASSY AT CLOSING TIME ON MARCH 31 AND ASKED TO SEE POLCOUNSELOR MICHAEL DURKEE (HE DEPARTED POST IN 1984. CURRENT POLCOUNSELOR WAS IN ANOTHER MEETING.) AFTER BEING ESCORTED TO THE POLITICAL SECTION, SHE IDENTIFIED HERSELF TO POLOFF, DECLINED TO TAKE A SEAT AND STATED THAT SHE HAD COME TO LET THE EMBASSY KNOW THAT SHE COULD CORROBORATE THE TESTIMONY OF ARMANDO FERNANDEZ LARIOS AND THAT SHE WAS WILLING TO TESTIFY BEFORE A U.S. GRAND JURY IF NECESSARY. SHE THEN SAID THAT HER ONLY MOTIVE WAS TO GET THIS OFF HER CHEST AND SHE TURNED TO LEAVE. POLOFF SUCCEEDED IN CONVINCING HER TO STAY BY ASKING A SERIES OF QUESTIONS REGARDING THE CASE.

4. CALLEJAS IS OF THE OPINION THAT THE U.S. WILL REOPEN THE INVESTIGATION AND THUS EXPECTS THAT ADDITIONAL GRAND JURY TESTIMONY WILL BE REQUIRED. SHE FEELS THAT THE GOC WILL CONTINUE TO PROSECUTE THE PASSPORT FRAUD CASE AGAINST CONTRERAS AND ESPINOZA BUT THAT IN THE END THEY WOULD BE FOUND INNOCENT. SHE EXPRESSED SOME SURPRISE THAT SHE HAD NOT RECEIVED ANY THREATS OVER THE PAST FEW MONTHS, SINCE SHE HAD BEEN INTERVIEWED ON NUMEROUS OCCASIONS AND HAD EXPRESSED HER SUPPORT

5. CALLEJAS IS WORKING AS A WRITER AND LIVES ON A LARGE ESTATE IN THE FASHIONABLE LO CURRO SECTION OF SANTIAGO. SHE SAID THAT SHE HAD SUCCEEDED IN GETTING TWO BOOKS PUBLISHED BUT ONLY AFTER GREAT DIFFICULTY. ONE BOOK, SHE SAID, HAD ONLY BEEN PUBLISHED AFTER IT HAD RECEIVED A PRESTIGIOUS AWARD, AND EVEN THEN IT WAS ONLY GIVEN LIMITED DISTRIBUTION. SHE BLAMED THE GOC FOR HER PROFESSIONAL DIFFICULTIES.
