IN RESPONSE TO ILLEGAL NARCOTICS TRAFFICKING, THE GOM HAS REQUESTED US ASSISTANCE IN ESTABLISHING NEAR REAL-TIME COMMUNICATIONS CONNECTIVITY BETWEEN THE COUNTRY TEAM AND GOM NORTHERN BORDER RESPONSE TEAMS, THE COUNTRY TEAM AND NORAD/C3I/EPIC FOR TIME SENSITIVE AIR DATA, AND AUTOMATION/ANALYTIC SUPPORT TO FUSE COUNTRY TEAM INFORMATION DATA BASES.
