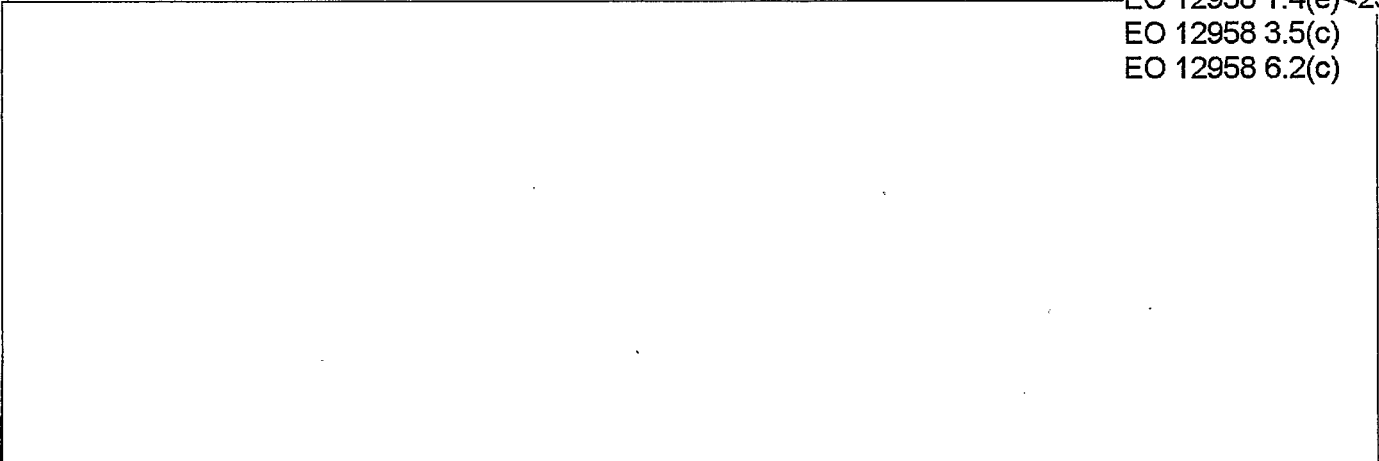

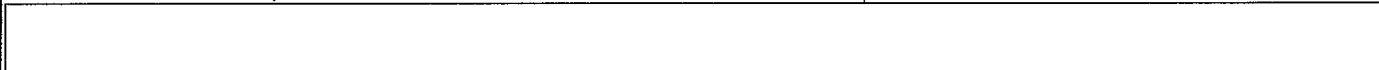

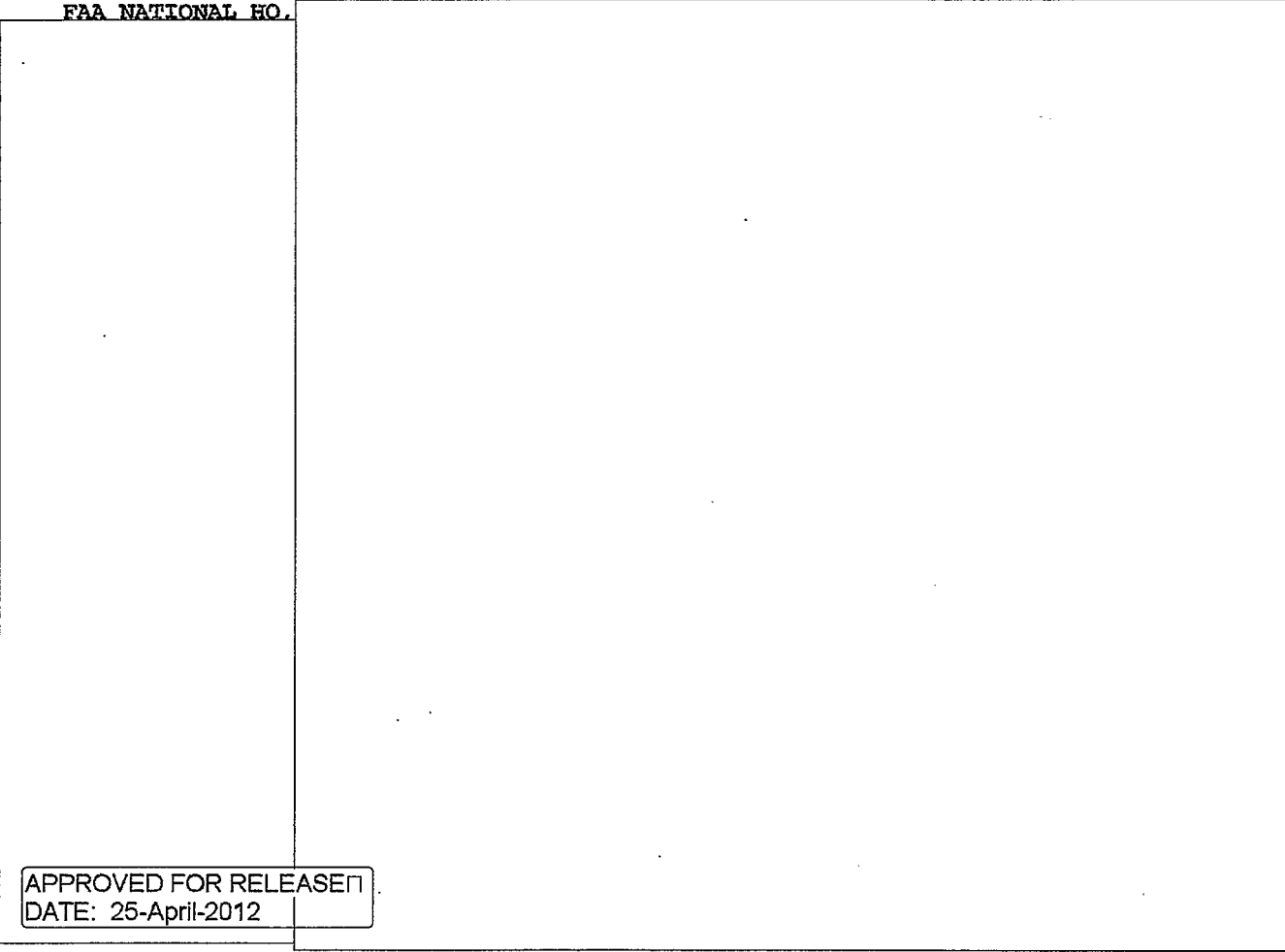

SUMMARY: ISLAMIC EXTREMIST FINANCIER USAMA BIN LADIN REPORTEDLY HAS BEEN INVOLVED IN ATTEMPTS TO ACQUIRE URANIUM [REDACTED] AND ALLEGEDLY MAY HAVE BEEN EXPLORING THE POSSIBILITY OF MOUNTING OPERATIONS WITH WEAPONS OF MASS DESTRUCTION.
