2. Initial estimates of the Gray Major's plan are confirmed to date by events. Two stolen devices were intended for placement and detonation one in Montrey, the other in CONUS. One probable device is located in a box is apparently confirmed by radiation readings, on the second level of the tower at Cinco North. Extensive booby trapping of Cinco North tower provents close approach to suspected device as of this report.

valid estimate.

3. No information or evidence indicates the primary goal of this combined operation of two states, initiated by the Gray Major. The extensive booby trapping of the North tower device seems to indicate that the plan scenario now unfolding requires time for an event prior to either the timed or accidental detonation of the device. It is possible that this "window" may be intended to allow time for a demand or for completion of another phase of the operation perhaps installation of the CONUS device.

BEHAVIORAL ASSESSMENT:

CONCLUSIONS:

The adversary appears to have a high degree of resolve in achieving his goals. He is planful and prepared to sacrifice his own members to achieve them. He appears fully rational, coherent, and "cold-blooded", intent on pursuing his course, making no attempt to date to communicate any rationale for his actions, to impose demands on anyone, or to explicitly formulate a threat, as in a verbal communication, to anyone.

His immediate objective in Montrev appears partly to be to "buy time", presumably to obtain sufficient time to fully develop the projected CONUS threat. The loss of men in the 12/7 assault strike might best be evaluated as a loss of "pawns" that the adversary willingly incurred in order to obtain time to put other pieces in place in CONUS.

RATIONALE:

- 1. From to outset, the adversary's plan has been very complex and comprehensive, involving a number of nations and a number of phases.
- 2. The adversary has made none of the traditional moves in a threat, namely, a threat, a demand, or a rationale for his actions, suggesting that he is in control within a more complex plan.
