THE MITH THE ABOVE I REITERATED TO ..... EXPRESSIONS OF OUR FRIENDSHIP, PROVED BY OUR ACTIONS FOR PRESIDENT SCHEVERRIA PERSONALLY AND FOR OUR NEIGHBOR REPUBLIC OF MEXICO. I REVIEWED THE MANY MATTERS ON WHICH WE HAD ACTED IN A COOPERATIVE FASHION AND HAD STRIVEN TO MEET MEXICAN ASPIRATIONS BOTH ON A BILATERAL PLANE AND ON MULTI-LATERAL MATTERS. I TOLD HIM OF OUR FIRM RESOLUTION TO CONTINUE STRIVING TO DO SO BUT STRESSING THAT WE ARE CONCERNED THAT CONFRONTATION LANGUAGE WAS CREATING AND MEXICO AND MADE IT MORE DIFFICULT FOR BOTH GOVERNMENTS TO CARRY OUT THE RELATIONSHIPS OF COOPERATION FOR WHICH WE WERE WORKING.

7, .... SAID HE WOULD FAITHFULLY TRANSMIT MY WORDS TO THE PRESIDENT, HE IMPLIED, HOWEVER, THAT ECHEVERRIA AND HIS CLOSE COLLABORATORS SEEMED TO FEEL THAT THE ALLEGATIONS AGAINST THE CIA HAD BEEN NOT DNLY A USEFUL: BUT A NECESSARY TACTIC WHICH WOULD PAY DIVIDENDS AND SPOKE OF PRESIDENT ECHEVERRIA'S ADMIRATION AND PERSONAL FRIENDSHIP FOR THE US. I STRESSED TO HIM THAT THERE WAS A DIFFERENCE BETWEEN PRIVATE FRIENDSHIP AND PUBLIC CONFRONTATION. I DID NOT EXPECT MEXICO NOW TO BECOME "A RUNNING DOG" BUT, THAT I WOULD THINK THAT A. RETTER BALANCE WOULD BE STRUCK IF THE PRESIDENT WOULD FIND IT POSSIBLE TO MAKE SOME PUBLIC EXPRESSIONS OF WARMTH AND FRIENDSHIP IN REGARD TO THE US EVEN IF NOT DIRECTLY CONNECTED TO THE CIA ALLEGATIONS. I SUGGESTED THAT AS THE PRESIDENT WOULD ADDRESS THE FINAL SESSION OF THE FORTHCOMING JOINT INTER-PARLIAMENTARY MEETING THIS MIGHT BE AN OCCASION FOR SOME PUBLIC EXPRESSIONS OF WARMTH WHICH MIGHT BE HELPFUL.

8. IN CLOSING, I TOLD HIM THAT I RECOGNIZE FULL WELL THAT WE ARE ABOUT TO ENTER INTO PERIOD OF TENSIONS
