3. YOU SHOULD STATE THAT WE VIEW THE ACTION AGAINST TIMERMAN, WHICH APPEARS TO HAVE BEEN MADE WITHOUT DUE LEGAL PROCESS, TO BE EXCEPTIONALLY UNFORTUNATE AT THIS TIME.

4. YOU SHOULD INFORM THE ARGENTINES THAT WE ARE DEEPLY CONCERNED OVER LACK OF PROGRESS ON DETAINEES, THE VERY

SLOW AND LIMITED APPLICATION OF THE RIGHT OF OPTION, AND CONTINUED DISAPPEARANCES AND REPORTS OF TORTURE.
WE HAVE EXPRESSED OUR CONCERN ABOUT ALEJANDRO DEUTSCH, EPIFANIO MENDEZ, AND MANY OTHER DETAINEES AND DISAPPEAREDS. YET WE HAVE HAD ONLY LIMITED RESPONSE. INCIDENTS SUCH AS THE ONES MENTIONED ONLY REEMPHASIZE THE CONTINUING CRITICAL STATE OF HUMAN RIGHTS.
