PERSONNEL TO BE EMPLOYED IN THE OPERATION INCLUDED THE SNIPER,
THE DRIVER AND THE FOUR BODYGUARDS, AS I HAVE SAID. THE PLAN ALSO
INCLUDED THE USE OF A CAR.

WELL, TO GIVE IT AN APPEARANCE OF LEGALITY, THE OPERATION WAS
ENTRUSTED TO THE NATIONAL POLICE, AND SOME OFFICERS OF THE
REPRESSIVE CORPS WERE PLACED IN CHARGE OF CONDUCTING THE MOCK
INVESTIGATION OF THE ASSASSINATION.

WHEN RICARDO RAMIREZ RAUDA BEGAN GATHERING EVIDENCE POINTING
