SEVERAL DAYS LATER, ALSO AFTER DARK, SEVERAL GUNMEN IN A GOVERNMENT VEHICLE SPRAYED THE RECTOR'S HOME WITH MACHINE GUN FIRE.

WHY IT MAY INDEED HAVE BEEN THE ARMY

HAS NO DOUBT THAT ALL THESE INCIDENTS WERE MILITARY ACTION. ARMY VEHICLES WERE SEEN AT THE COLONIO KILLING AND DURING THE OCTOBER, 1989, ATTACK ON THE UNIVERSITY. WHEN THE ARMY RAIDED THE CAMPUS IN MAY, TWO NIGHTWATCHMEN WERE BLINDFOLDED BY THE INVADERS. HOWEVER, WAS OUT ON ROUNDS AND HID HIMSELF AS HE WATCHED SOLDIERS DRIVE IN AND DUMP THE BODY.

ARAMBURU CLAIMED HE HAD PROVIDED THE MEDICAL HELP UNDER THE THREAT SAID THAT HIS FRIEND FEARED THAT OF DEATH. THE MILITARY WOULD FIND OUT.

COMMENT: NONE OF THE WITNESSES TO THESE EVENTS, OR TO MOST OTHER INCIDENTS OF VIOLENCE ATTRIBUTED TO THE MILITARY OR POLICE IN AYACUCHO, IS WILLING TO MAKE FORMAL ACCUSATIONS AGAINST THE FORCES OF ORDER. EVERY WITNESS WHO CAME FORWARD FOLLOWING THE CAYARA MASSACRE HAS DIED SIMILARLY, THOSE WHO SAW THE KILLING OF OR DISAPPEARED. CARETAS REPORTER HUGO BUSTIOS. WITH NO FORMAL EYEWITNESS TESTIMONIES TO ANY OF THESE CASES OF ALLEGED ARMY OR POLICE VIOLENCE, THE MOST WE CAN STATE IS THAT THERE IS EVIDENCE OF OFFICIAL RESPONSIBILITY. END COMMENT.
