1. I MET WITH SOUTOU THIS MORNING AND GAVE HIM DETAILED RUN-DOWN ON THREE ASSURANCES WE REQUESTED OF SOUTH AFRICANS AND THE RESPONSES WE HAVE THUS FAR RECEIVED. HE WAS APPRECIATIVE OF OUR KEEPING THE FRENCH INFORMED AND CONCLUDED FROM THIS INITIAL PRESENTATION, AT LEAST, THAT SOME PROGRESS HAD BEEN MADE BUT THAT SERIOUS PROBLEMS STILL REMAIN TO BE FACED.

2. SOUTOU SAID THAT THE SOUTH AFRICAN RESPONSE TO THE FRENCH DEMARCHE HAD BEEN, FIRST, THAT ALL OF THE SOUTH AFRICAN NUCLEAR PROGRAM IS FOR PEACEFUL PURPOSES, AND, SECOND, FROM THE CONTEXT OF ALL REMAINING DISCUSSIONS, THE SOUTH AFRICANS WERE ASKING HOW THEY COULD ASSURE THE WORLD THAT THEY WERE NOT DEVELOPING A NUCLEAR EXPLOSIVE OF ANY KIND. HOWEVER, MAKE A FLAT STATEMENT AS THEY HAD APPARENTLY NOW DONE TO US THAT THEY WERE NOT CREATING EVEN A TEST FACILITY FOR NUCLEAR EXPLOSIVES.

SOUTOU WENT ON TO APOLOGIZE FOR WHAT HE REFERRED TO AS A "MISTAKE" BY HIS MINISTER IN TALKING TO THE PRESS, HE SAID THAT HE WAS VERY TIRED AT THE END OF HIS AFRICAN TRIP AND DURING THE COURSE OF AN INTERVIEW DE GUIRINGAUD SLIPPED AND APPEARED TO CONFIRM THAT FRANCE HAD BEEN TOLD THAT SOUTH AFRICA WAS PROCEEDING WITH PREPARATIONS FOR A NCULEAR TEST BUT THAT THIS WAS FOR PEACEFUL PURPOSES. SOUTOU SAID THAT AS WE CAN SEE FROM HIS ACCOUNT OF THE RESPONSE THEY HAVE RE-CEIVED FROM THE SOUTH AFRICAN GOVERNMENT THAT IS NOT ALL AN ACCURATE STATEMENT OF WHAT THE SOUTH AT HE EXPRESSED SOME CONSTERNATION AND AFRICANS SAID. KNOW WHETHER THE SOUTH AFRICANS HAD ACTUALLY REFUSED INSPECTION OR WHETHER, IN VIEW OF THE SHORT TIME PRESSURES, WE HAD NOT WAITED FOR AN ANSWER BUT PROCEEDED WITH THE REQUEST FOR ASSURANCES AS A PARALLEL MOVE.
