Subject: Exercise IVORY ITEM (U)

1. (TS) As a follow-on to the Command Conference Test conducted by the Secretary of Defense on 10 May, the first IVORY ITEM Exercise, conducted 12 May, met the objective of familiarizing the participants with the purpose of the missile attack conference and the NORAD threat assessment function.


2. (U) Some observations concerning the exercise follow: The quality of the secure conference can be degraded by speakers or extension phones which are off hook. The overall time required to conduct the exercise can be reduced by combining the two preamble conferences. The problems involved in secure conferencing are recognized, but we will endeavor to reduce that time to the absolute minimum.

3. (e) To streamline future IVORY ITEM exercises, the Deputy Director for Operations (DDO-NMCC) will convene a nonsecure conference of addressees, or their Vice or Operations Deputy, and the nuclear Commanders in Chief under the provisions of Volume IV, EAP-JCS. Addressees or their alternates will be included only if available at an NMCC direct line emergency telephone. The following preamble will be used.

"THIS IS THE COMMAND CENTER WITH AN EXERCISE IVORY ITEM PREAMBLE FLASH TEST CALL. PLACE YOUR COMMANDER OR CHIEF OR HIS DESIGNATED ALTERNATE ON THE LINE IMMEDIATELY."

roll call will be conducted of conferees in conjunction with a verification of the "IVORY ITEM NUMBER", i.e., the secure telephone number at which each conferee can be contacted for the impending IVORY ITEM Conference and the estimated time required to reach that location. The NMCC will then release the conference by stating, "STANDBY FOR AN EXERCISE IVORY ITEM CONFERENCE IN (XX) MINUTES. COMMAND CENTER OUT."

4. -(C) The nonsecure conference will be followed by a secure telephone conference of all participants at the specified time. The secure conference will be convened using the following preamble: "THIS IS THE COMMAND CENTER WITH AN EXERCISE IVORY ITEM FLASH TEST CALL" (repeated at least four times).

5. (U) Conferees should be placed on the line immediately upon hearing "FLASH TEST CALL" and remain silent until a roll call is conducted of the Washington principals and the CINCs. At this time use of speakers and extension telephones must be discontinued. Following the roll call, the individual initiating the exercise will be added to the conference.

6. (6) The next exercise may involve a brief threat scenario to be presented by CINCNORAD/ADCOM. The scenario portion of the conference will terminate at the point at which recommendations would be formulated.

7. (U) Following questions and discussion, the conference will be terminated by the initiator.

8. (U) The vulnerability period for no-notice IVORY ITEM Exercises continues daily during Washington duty hours (1200 - 2100Z).

9. (U) Addressees are requested to acknowledge receipt of these instructions to the DDO-NMCC, secure 2600.
