THE ASSISTANT TO THE CHAIRMAN CINCAD has requested reconsideration of his request to use a desktop telephone speaker ADMINISTRATIVE located in the battle staff area of his ASSISTANT command post to respond to IVORY ITEM exercises CHAIRMANS STAFF GROUP CINCAD has temporarily installed such a AIR FORCE MBR device for local practice sessions and has CHAIRMANS STAFF GROUP confirmed not only its utility but also the NAVY MBR consistently good quality of voice communica-CHAIRMANS STAFF GROUP In March, the Acting CJCS (GEN Rogers) MARINE MBR denied his request, highlighting the sensitive CHAIRMANS STAFF GROUP nature of the IVORY ITEM exercise and the ARMY MBR requirement to limit conference participants. LEGAL ADVISOR AND CINCAD believes, however, that he can better LEGISLATIVE ASST 01F support the NCA decision-making process with SPECIAL ASSISTANT the aid of his IVORY ITEM support team. 01G (SPEECHES) team is limited only to those immediate staff members whom he considers essential for support. MARINE AIDE The proposed message to CINCAD points out that ARMY AIDE the privacy requirement has been imposed by highest authority. Only those persons absolutely required to conduct the exercise are authorized access to IVORY ITEM conferences Within those guidelines, the proposed message would grant CINCAD's request.
