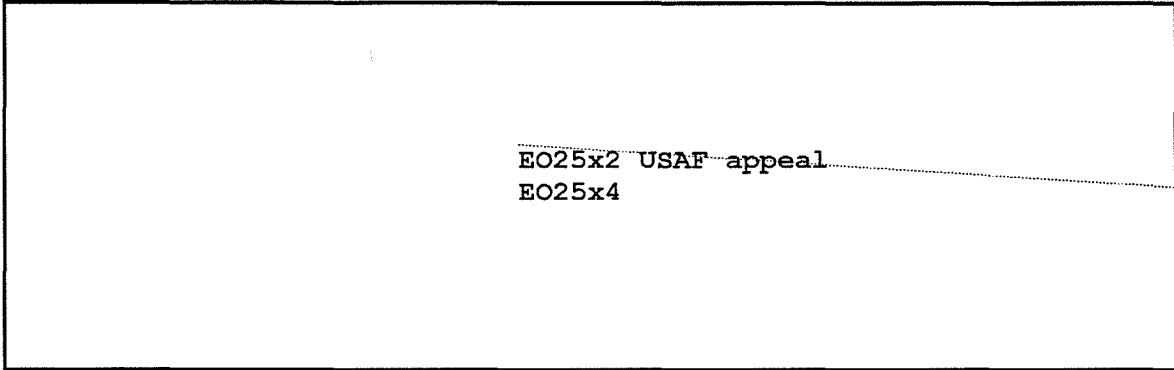
REMARKS
