(C) SUMBARY: MILITARY OFFICIALS HAVE BEEN IMPLICATED IN THE MARCH 4 KILLINGS IN URABA. A RECENTLY COMPLETED 6. (C) CORDOBA -- NO EASY ANSWERS: ON APRIL 22, POLOFF STUDY BY THE DAS (FBI EQUIVALENT), OF WHICH THE PRESS TRAVELED TO MONTERIA, CORDOBA DEPARTMENT, TO DISCUSS THE HAS OBTAINED A COPY, HAS CONCLUDED THAT MILITARY MEMBERS SECURITY SITUATION WITH OF THE B-2 (INTELLIGENCE) IN URASA IDENTIFIED PEOPLE BELONGING TO THE SUPPORT NETWORK FOR THE EPL (ARMY OF NOT CLE W POPULAR LIBERATION). THESE SAME PEOPLE WERE SUBSEQUENTLY MURDERED ON MARCH 4. A MILITARY SPOKESMAN quennillas DENIED THAT THE REPORT INGRIMINATED THE MILITARY. CONTENDING THAT IT MERELY RELATED UNPROVEN TESTIMONY ACCUSING THE MILITARY OF INVOLVEMENT. MINISTER OF DEFENSE SAMUDIO DENIED ANY MILITARY INVOLVEMENT IN REMARKS TO THE PRESS ON MAY 5. HE SAID "SINISTER TROOPS. THEY MUST MOVE ON FOOT. FORCES" WERE TRYING TO DEFAME THE MILITARY. POLOFF'S VISIT TO MONTERIA, THE CAPITAL OF CORDOBA DEPARTMENT, REINFORCED THE VIEW THAT THE SITUATION IN NORTHERN COLOMBIA REMAINS COMPLEX AND RESISTS EASY SOLUTIONS. END SUMMARY 2. (C) THE URABA REPORT: THE WEEKLY NEWS MAGAZINE SEMANA PUSBLISHED MAY 3 A REPORT ON THE MURDERS IN URABA IN EARLY MARCH. THE REPORT DRAWN FROM A CONFIDENTIAL DAS REPORT CONCLUDED THAT IN THE KILLINGS AF THE "LA HONDURAS" AND "LA NEGRA" FARMS IN URABA ON MARCH 4, THE VICTIMS WERE PART OF THE EPL GUERRILLA ORGANIZATION'S SUPPORT GROUP: THAT IN THE WEEKS PRECEDING THE KILLINGS, MEMBERS OF THE HILITARY CARRIED OUT OPERATIONS DESIGNED TO IDENTIFY MEMBERS OF THE GUERRILLA GROUP; THAT DESERTERS FROM THE EPL COLLABORATED WITH THE

BOGOTA 87875 88 OF 82 8813212 RESTREPO AS SAYING THAT ANY COOPERATION BETWEEN THE MILITARY AND SELF DEFENSE GROUPS INVOLVED IN THE MASSACRE SHOULD BE BROUGHT BEFORE MILITARY COURTS. MINISTER OF JUSTICE LOW MUSTRA AND ATTORNEY GENERAL HORACIO SERPA AGREED WITH THE SENT: MENT, BUT SAID CIVILIAN COURTS WOULD TRY THE OFFENDERS. SERPA, IN A MAY 4 PRESS CONFERENCE, ALSO SAID THAT MEMBERS OF THE MILITARY ARE UNDER INVESTIGATION FOR HUMAN RIGHTS VIOLATIONS, BUT HE DENIED THAT THEY ACTED IN THE NAME OF THE STATE. - (U) THE LEFTIST PATRICTIC UNION (UP) HAS USED THE REPORT TO CONTINUE ITS ATTACK AGAINST THE NEWLY NAMED MILITARY CHIEF IN URABA, CLAIMING THE APPOINTMENT GIVES SECURITY FORCES A "GREEN LIGHT" FOR FURTHER HUMAN RIGHTS. VIOLATIONS,
- 5. (U) NEW DEVELOPMENTS "IN CORDORA KILLINGS: HEANWHILE, BOGOTA DAILY "EL TIEMPO" ON MAY 6 REPORTED THAT AUTHORITIES HAVE ARRESTED NINE PEOPLE SUSPECTED OF INVOLVENENT IN THE HEJOR ESCUINA, BUENA VISTA, "EASTER" MASSACRE IN CORDOBA (BOGOTA 5442). THE NEVSPAPER REPORT GLAIRS THAT THE NINE ARRESTED WERE PLANNING-ADDITIONAL ATTACKS AGAINST MEMBERS OF THE UP AND OTHERS THEY VIEWED AS SUFPORTERS OF THE GUERRILLAS.

CONVERSATION FOCUSED PRIMARILY ON THE EPL THREAT IN ESTIMATED THAT TOTAL GUERRILLA STRENGTH CORDOBA. IN THE DEPARTMENT WAS LESS THAN 200 FICHTERS, BUT THAT THAT NUMBER IS BOLSTERED BY AN INTELLIGENCE AND SUPPORT HETWORK (hosca--Flies) That supplies the guerrillas with INFORMATION ON TROOP MOVEMENTS. SINCE THE BRIGADE HAS NO HELICOPTERS OR SUFFICIENT TRANSPORT FOR ITS 4000

7. (C) TO MAKE UP FOR MATERIAL SHORTAGES, ACCORDING TO
THE BRIGADE RELIES ON UNORTHOBOX TACTICS
AND INTELLIGENCE. EXPLAINED THAT HE DECIDES
WHEN, WHERE AND HOW HE WILL ATTACK, SAYING "I DON'T ASK
THOSE ABOVE FOR ANYTHING BUT HELICOPTERS, VEHICLES, AND
BULLETS." PCKNOWLEDGED OCCASIONAL MATERIAL
SUPPORT, SAYING THAT FOR ONE OPERATION DURING HOLY WEEK
HE RECEIVED FOUR HELICOPTERS. THIS ALLOWED HIM TO
ASSAULT GUERRILLA STRONGHOLDS IN THE SERRANIA OF SAN
JERONINO, RESULTING IN THE DEATH OR VOUNDING OF 38
INSURGENTS.

3. (U) REACTION: THE MAY 4 EDITION OF BOGOTA CONSERVATIVE DAILY "EL SIGLO" QUOTES EX-PRESIDENT LLERAS

MILITARY IN MAKING THE IDENTIFICATIONS; AND THAT THE DESERTERS MAY HAVE SUBSEQUENTLY PARTICIPATED IN THE KILLINGS. THE REPORT DIO NOT RULE OUT THE FACT THAT MILITARY PERSONNEL HIGHT ALSO HAVE PARTICIPATED IN THE MILLINGS. IT CONCLUDED THAT THIS TYPE OF "CLEAN-UP OPERATION" ("OPERACION LIMPIEZA") WAS BEING FINANCED BY LOCAL LANDOWNERS WHO WERE FED UP (DESESPERADOS) WITH THE QUERRILLAS. SOME OF THE EPL DESERTERS SAID THAT SECURITY FORCES FORCED THEM TO IDENTIFY WORKERS INVOLVED IN EPL EXIORTION (BOLETEO) OR OTHER SUPPORT ACTIVITIES.

9. (C) THEN ADDRESSED THE KILLING OF 48 PEOPLE

18. (C) COMMENT: NORTHERN COLOMBIA CONTAINS ELEMENTS OF ALL THE CAUSES OF VIOLENCE IN THE COUNTRY. EVEN HENRY VELASCO, THE CIVILIAN HUMAN RIGHTS WATCH DOG FOR THE MILITARY, HAS TOLD POLCOUNS THAT THE MILITARY IS INVOLVED. HE WAS CAREFUL TO POINT OUT, HOWEVER, THAT HE THE HILITARY IS INVOLVED AS INDIVIDUALS. THERE IS NO INSTITUTIONAL SANCTION FOR HUMAN RIGHTS VIOLATIONS, AND THOSE WHO ARE INVOLVED IN BREAKING THE LAW WILL BE PUNISHED, HE SAID. WHAT EMERGES FROM THE ABOVE IS THAT COMMANDERS IN RURAL AREAS ARE OFTEN LEFT ON THEIR OWN WITH FEW RESOURCES IN AREAS WITH HIGH RATES OF VIGLENCE. UNDER SUCH CIRCUNSTANCES, THEY ARE PROHE TO USE THE RESOURCES AT HAND, WHICH HAY BE LOCAL RANCHERS (INCLUDING MARCOS) WHO, IN THE ABSENCE OF LEGALLY CONSTITUTED AUTHORITY, PAY "SELF DEFENSE" GROUPS TO PROTECT THEIR INTERESTS. COMMANDERS FACED WITH MAINTAINING SOCIAL ORDER, BUT WITH LITTLE MATERIAL SUPPORT, MAY VIEW COOPERATION WITH LOCAL GROUPS AS THE ONLY SOLUTION TO THE PROBLEM.
