It appears that they were Sendero, although no one has really confirmed that because none were captured and there have been no reliable reports yet of the captive's stories. Sendero fled and the army moved in. The WSJ report was in error when they reported 30 were released, at that time. The army is pursuing the kidnappers. Army plans to increase security for this area of pipeline. TGA has not disclosed if any sort of ransom was paid; there are reports of that, but it may be that army closing in caused Sendero to flee.
